**APPLICATION CRITERIA-**



**1. Eligibility Criteria**

1. The applicant should have a minimum of three (03) years’ experiences in the Supply Chain Management practices.
2. He / She should have a significant contribution in the sphere of Supply Chain Management at national or organizational level as well as any innovations or major contributions or major projects conducted/made in the field of Supply Chain.
3. Should be a responsible head in the respective division.
4. Council members/Subcommittee members/ staff of ISMM will **not eligible** to apply.
5. Age should be above 18 years.

**2. Benefits to Winners**

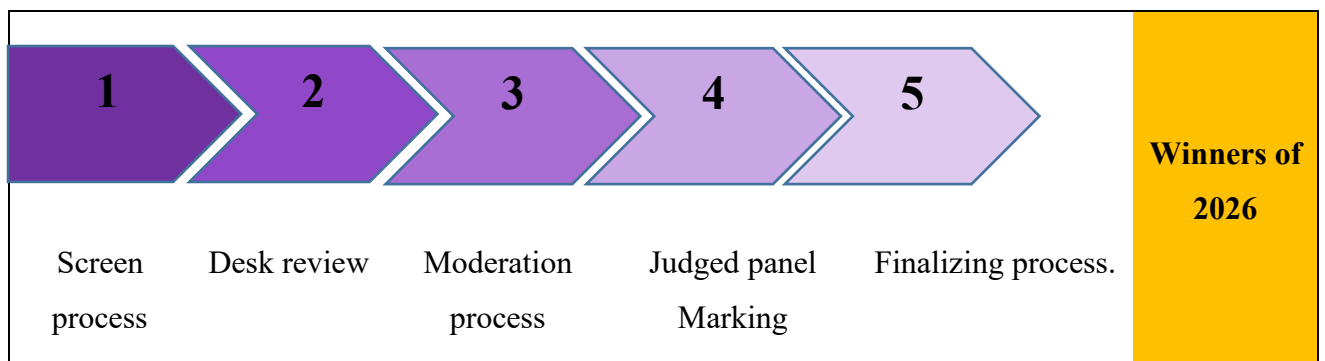
1. Recognize the Best Practitioner in the field of Supply Chain Management
2. Motivate the Supply Chain Professionals in their career development.
3. Create a platform to exhibit their best practices and bench mark.

**3. Main Award Categories**

1. The “Best Supply Chain Professional 2026” two categories of Corporate and Business
2. 1<sup>st</sup> runner-up of the “Best Supply Chain Professional 2026” of Corporate and Business
3. 2<sup>nd</sup> runner-up of the “Best Supply Chain Professional 2026” of Corporate and Business
4. Special commendations for Professionals in Supply Chain Management.

**4. Evaluation Process**

Applications are evaluated in a Five-stages process as described below,



1. Applicants who obtain 50 marks and above from the Desk Review are eligible to go through the judge panel interviews.
2. Winners of the Best Supply Chain Professionals should obtain 80 marks and above from the Desk Review under the discretion of Selecting Committee.

- Your application to be certified by your immediate Supervisor / CEO / Managing Director / Chairman Signed over a **rubber stamp**
- You are requested to use only the given format.
- Attach evidences with certified true copies of your immediate supervisor
- **Incomplete applications will be rejected.**

**6. The Application and Submission Process**

The completed application along with required supporting documents should be submitted to ISMM as per the instructions given below.

### 6.1 Document Type:

All documents should be submitted in **hard copies** with suitable binding (Spiral or Hard) on or before due date.

### 6.2 Details of submission Fees:

You are required to pay a submission fees of **Rs.10,000.00** at the time of obtaining the application to ISMM. Please attached the receipt copy with the application. If the receipt copy is not properly attached, your application can considered for **rejection the application.**
